8. Project Manager Update

Briefly discussed project manager report. CP noted fence installed around Matilda Birkett to prevent trail bike riders damaging area.

DC mentioned the shade cloth installed around Stock Road is very neat, although raised issue of the bank of veldt grass within the shade cloth outside the project management area and suggested slashing. FB noted the shade cloth will prevent rubbish from entering the area.

CP noted Aboriginal weaving event sold out and SH thanked CA for hosting. CP mentioned the Community Questionnaire finished on 7 April and received 120 submissions; FB noted Danielle Brady worked hard to expand reach.

FB discussed the media release for the Cockitrough and a viewer had misinterpreted as a commemoration.

DC mentioned the bee hotels made from the Native Bee workshop made by the community are valuable in the corridor and provide a nice explanation of their purpose.

CA provided an update on the budget. DC and FB raised concerns for watering and weed control if those items were reduced and would decrease success of the project.

PC queried if there was any financial influence from DBCA within Regional Parks and how it is delivered within the corridor and CP responded it is separate for the 10-year period during the RR8 management.

 - Committee is happy with the general layout and agreed the acknowledgement at the start was good and preferred the static not pop-up.
 - PC mentioned the acknowledgement should state "and/or" for Aboriginal and/or Torres Strait Islanders and "Beeliar people".
 - SH suggested the acknowledgement should not be finalized until there is aboriginal representation on the committee. PC suggested forwarding to Gail Beck to assist in updated wording.

FB – Transport and traffic forum and encourages a bus service around Bibra Lake and from train station as it has lots of recreation and lack of bus services and parking – WA Wildlife, the Wetlands Centre, Adventure world, Ice Arena, Aboriginal Cultural Centre and skatepark. Peter Tinley and City of Cockburn attended meeting. The Wetlands Centre – Cultural Education Program 28 April, 9am to 3pm. Submitted first RAP (Reconciliation Action Plan) and will be hosting Cultural Community Day shortly. The Wetlands Centre nursery is now growing seedlings from cuttings and nursery might be able to assist for recalcitrant species in the corridor.
